BID NO: 10/16/17 – PACKAGE B: GUARD HOUSES, SECURITY FENCE GATES & DRIVEWAY

Mandeni Municipality hereby invites bidders from suitably qualified and experienced contractors for the Construction of new guardhouses, upgrading of existing access roads and parking area as well as the erection of new fences and gates at the Mandeni Municipality. Only Bidders who are registered with CIDB in a contractor grading of **6GB** or higher will be eligible to bid. In case of Partnership /Joint Venture consolidated CIDB Registration Certificate must be attached. Bidders will have proof of CIDB Registration by the closing date failing which their Bid will be disqualified.

The physical address for purchase of bid documents is: Mandeni Municipality, Civic Centre, 2 Kingfisher Road, Mandeni (cashiers office). A non-refundable fee of R500.00 (inclusive of VAT), will be charged per document (**cash or bank guaranteed cheques only**). **Bid documents will be available during the hours: Monday-Friday 08H00 – 15H30 from Wednesday 22 February 2017. The cut-off time for selling of bid documents is 15h30 on Thursday, 02 March 2017.**

A **compulsory clarification meeting** with representatives of the Employer will take place at the Mandeni Civic Centre, 2 Kingfisher Road, Mandeni on **Friday, 03 March 2017, starting at 10h00** thereafter proceeding to the site. Failure to attend the compulsory clarification meeting will disqualify the bid.

Bids shall be placed in sealed envelopes, endorsed "**BID NO.: 10/16/17 "Construction of new guardhouses, upgrading of existing access roads and parking area as well as the erection of new fences and gates at the Mandeni Municipality"** and be placed in the Tender Box situated at the reception: Civic Centre, 2 Kingfisher Road, Mandeni, not later than **12h00, on Friday, 10 March 2017** at which time the bids will be opened in public. **Closing time will ONLY be determined by the Municipal clock at the reception.** Bids are to be submitted on the bid documentation provided by the Municipality. Late submission, electronic or faxed bids will not be accepted. **Only Bidders registered on Mandeni Supplier Database and Central Supplier Database (CSD) will be considered.**

The Mandeni Municipality subscribes to the preferential procurement policy framework Act, Act No. 5 of 2000 and it's associated Regulations of 2011. The 90/10 principal applies to this bid. Bids shall be valid for a period of 90 days. The Mandeni Municipality does not bind itself to accepting the lowest bid, either wholly or in part or give any reason for such action. All prospective bidders will be screened in accordance with the National Treasury's Defaulters Data Base. Canvassing in any form in the gift of Council is strictly prohibited and will lead to the disqualification of the bid.
