
SPATIAL PLANNING AND LAND USE MANAGEMENT ACT, 2013 (ACT No. 16 of 2013) READ WITH SECTION 46 OF THE MANDENI LOCAL MUNICIPALITY SPATIAL PLANNING AND LAND USE MANAGEMENT BYLAW NO. 1562 GAZETTED ON PROVINCIAL GAZETTE 2015: INVITATION TO COMMENT ON PROPOSED SUBDIVISION OF LOT 686 SUNDUMBILI B.

The Mandeni Local Municipality has prepared an application for the subdivision of its property ERF 686 Sundumbili B in terms of Section 33 of the Spatial Planning and Land Use Management Act, 2013 read with Mandeni Local Municipality Spatial Planning and Land Use Management Bylaw No.1562 Gazetted on Provincial Gazette, December 2015, for the following:

- (a) Proposed subdivision of Lot 686 Sundumbili B into 4 portions (Namely Portion 4, 5, 6 and Remainder of Portion 6 of Lot 686 Sundumbili B.
