SERVICE PROVIDER TO MANUFACTURE, SUPPLY AND DELIVER BLACK AND YELLOW REFUSE BAGS BRANDED WITH MANDENI MUNICIPALITY NAME ON QUARTELY BASIS FOR THE DURATION OF THREE YEARS TO COMMUNITY SERVICES AND PUBLIC SAFETY DEPARTMENT.


Bidders are hereby invited from suitably service provider to manufacture, supply and deliver black and yellow refuse bags on quarterly basis for the period of three years to Community Services and Public Safety Department.

Bid documents will only be available at the cashiers, Civic Centre, 2 Kingfisher Road, Mandeni from **19 September 2019 until 03 October 2019 during working hours: Monday to Friday 08H00 to 15H00.** A non-refundable fee of R 500.00 amount will be charged per document (**cash or bank guaranteed cheques only**). There will be no selling of bid documents after **03 October 2019 at 15H00.**

Bid are to be completed in accordance with the conditions attached to the Bid document and must be sealed in an envelope and marked: **"BID NO.:03/19/20 "MANUFACTURE, SUPPLY AND DELIVER OF BLACK AND YELLOW REFUSE BAGS BRANDED WITH MANDENI MUNICIPALITY NAME.."** and must be deposited in the tender box situated at the reception: Civic Centre, 2 Kingfisher Road, Mandeni **no later than 12 H00, on 04 October 2019** at which time bids will be opened in public. Closing time will **only** be determined by the Municipal watch displayed on the Municipal wall at the reception. The name and address of the Bidder must be clearly written on the sealed envelope containing the Bid Document. **Late submission, e-mail or fax bids will under no circumstances be considered. Only bidders registered on Central Supply Database (CSD) will be considered.**

The Mandeni Municipality subscribes to the Preferential Procurement Policy Framework Act, Act No. 5 of 2000 and its associated Regulations of 2017. The 80/20 principle applies to this Bid. Bids shall be valid for a period of 90 of days The Mandeni Municipality does not bind itself to accepting the lowest, or any Bidder, either wholly or in part or give any reason for such action.
