
Mandeni Local Municipality hereby invited suitably qualified service providers and reputable service provider to submit their Bid to Supply and Delivery of **RIDE-ON-2.5 TON TANDEM VIBRATORY ROLLER WITH SUITABLE DOUBLE EXCEL TRAILER**.

Bid documents will only be available at the cashiers, Civic Centre, 2 Kingfisher Road, Mandeni from **19 September 2019 until 03 October 2019 during working hours: Monday to Friday 08H00 to 15H30**. A non-refundable fee of R500.00 will be charged per document (cash or bank guaranteed cheques only). There will be no selling of bid documents after **03 October 2019**.

Bids are to be completed in accordance with the conditions attached to the Bid document and must be sealed in an envelope and marked; **BID NO: 02/19/20 "Supply and Deliver of Ride-on 2.5 Ton Tandem Vibratory Roller with a Suitable Double Excel Trailer."** and must be deposited in the tender box situated at the reception: Civic Centre, 2 Kingfisher Road, Mandeni **no later than 12H00, 04 October 2019** at which time bids will be opened in public. **Closing time will ONLY be determined by the Municipal watch displayed on the Municipal wall at the reception.** The name and address of the Bidder must be clearly written on the sealed envelope containing the Bid Document. **Late bids or bids received by way of post, facsimile or e-mail will, under no circumstances, be considered. ONLY bidders registered on Central Data Base (CSD) will be considered and must provide proof of registration.**

The Mandeni Municipality subscribes to the Preferential Procurement Policy Framework Act, Act No. 5 of 2000 and its associated Regulations of 2017. The 80/20 principle applies to this Bid. Bids shall be **valid for a period of 90 days**. The Mandeni Municipality does not bind itself to accepting the lowest, or any Bidder, either wholly or in part or give any reason for such action. All prospective bidders will be screened in accordance with the National Treasury's Defaulters Database. Canvassing in any form in the gift of Council is strictly prohibited and will lead to the disqualification of the bidder.
