Bidders are hereby invited from suitably service provider to Supply and deliver 15 x 6 cubic meters steel refuse skips to Community Services and Public Safety Department



A non-refundable fee of **R 350.00** amount will be charged per document (**cash or bank guaranteed cheques only**). There will be no selling of bid documents after the **26 September 2019**.

A **Compulsory** clarification meeting with the representatives of the employer will take place at Sibusisiwe Hall, Mandeni on **Friday, 27 September 2019 starting at 10h00**. Failure to attend the compulsory clarification meeting will disqualify the tender.

Only bidders registered on Central Supply Database (CSD) will be considered.**

The Mandeni Municipality subscribes to the Preferential Procurement Policy Framework Act, Act No. 5 of 2000 and its associated Regulations of 2011. The 80/20 principle applies to this Bid. Bids shall be **valid for a period of 90 days**. The Mandeni Municipality does not bind itself to accepting the lowest, or any Bidder, either wholly or in part or give any reason for such action.
