BUILDING RENOVATIONS OF LOVE LIFE CENTRE

Bids are hereby invited from suitably qualified and experienced contractors for the Building Renovations of Love Life Centre together with associated works in the vicinity of Thokoza Road situated in Ward 7, Mandeni.

It is estimated that bidders who are registered with CIDB, in a contractor grading of 2GB or higher will be eligible to bid.

Bid documents together with drawings will only be available at the cashier's offices, Civic Centre, 2 Kingfisher Road, Mandeni from Thursday, 21 November 2019 to Thursday, 28 November 2019 during working hours **Monday to Friday from 08h00 to 15h45**. There will be **NO SELLING** of bid documents after 15h45 on Thursday, 28 November 2019. A non-refundable fee of R500.00 will be charged per document.


A **compulsory** briefing/Site Inspection meeting will be held at **10h00 on Friday, 29 November 2019**. Prospective bidders shall meet at the Isibusisiwe Hall thereafter proceeding to the site.

Bids are to be completed in accordance with the conditions attached to the Bid document and must be sealed in an envelope and marked: **"Bid Number 10/19/20: Building Renovations of Love Life Centre"** and must be deposited in the tender box situated at the reception: Civic Centre, 2 Kingfisher Road, Mandeni **not later than 12h00, on Wednesday, 11 December 2019** at which time bids will be opened in public. Closing time will **only** be determined by the Municipal watch displayed on the Municipal wall at the Reception. The name and address of the bidder must be clearly written at the back of the sealed envelope containing the bid. **Late bids or bids received by way of post, facsimile or e-mail will, under no circumstances, be considered.**

The Mandeni Municipality subscribes to the Preferential Procurement Policy Framework Act, Act No. 5 of 2000 and its associated Regulations of 2017. The 80/20 principle applies to this bid. Bids shall be **valid for a period of 90 days**. The Mandeni Municipality does not bind itself to accepting the lowest, or any tender, either wholly or in part or give any reason for such action.
