

A compulsory briefing meeting will be held on **Thursday 5th March 2020 at Sibusisiwe Hall at 10:00am**. Failure to attend the compulsory clarification meeting will disqualify the bid

Only bidders registered on Central Supply Database (CSD) will be considered.**

Bids shall be valid for a period of 90 of days. Mandeni Municipality does not bind itself to accepting the lowest, or any Bidder, either wholly or in part or give any reason for such action.
