Bids are to be completed in accordance with the conditions attached to the Bid document and must be sealed in an envelope and marked: **"PROVISION OF MFMP TRAINING FOR MANDENI MUNICIPALITY FOR NINE (9) OFFICIALS."** and must be deposited in the tender box situated at the reception: Civic Centre, 2 Kingfisher Road, Mandeni no later than **12H00, Friday 13th March 2020** at which time bids will be opened in public. **Closing time will ONLY be determined by the Municipal watch displayed on the Municipal wall at the reception.** The name and address of the Bidder must be clearly written on the sealed envelope containing the Bid Document. **Late bids or bids received by way of post, facsimile or e-mail will, under no circumstances, be considered. ONLY bidders registered on Central Data Base (CSD) will be considered and must provide proof of registration.**

The Mandeni Municipality subscribes to the Preferential Procurement Policy Framework Act, Act No. 5 of 2000 and its associated Regulations of 2017. The 80/20 principle applies to this Bid. Bids shall be valid for a period of 90 days. The Mandeni Municipality does not bind itself to accepting the lowest, or any Bidder, either wholly or in part or give any reason for such action. All prospective bidders will be screened in accordance with the National Treasury's Defaulters Database. Canvassing in any form in the gift of Council is strictly prohibited and will lead to the disqualification of the bidder.
