
The physical address for collection of bid documents is: Mandeni Municipality, Civic Centre, 2 Kingfisher Road, Mandeni (cashiers office) upon presentation of a receipt proving prior payment of a non-refundable fee of R500 (inclusive of VAT), (Cash or bank guaranteed cheques only).

Clarification meeting is not compulsory

Bids shall be placed in sealed envelopes, endorsed clearly with the 'bid name and relevant bid number' must be placed in the Tender Box situated at the reception: Civic Centre, 2 Kingfisher Road, Mandeni, not later than 12h00 (time will ONLY be determined by the Municipal clock at the reception) on Friday, 28 August 2020 at which time the bids will be opened in public. Bids are to be submitted on the bid documentation provided by the Municipality. Late submission, electronic or faxed bids will not be accepted.

Only Bidders registered on Central Supplier Database (CSD) will be considered and they must provide proof of registration.

The Mandeni Municipality subscribes to the preferential procurement policy framework Act, Act No. 5 of 2000 and its associated Regulations of 2017. The 80/20 principal applies to this bid. Bids shall be valid for a period of 90 days. The Mandeni Municipality does not bind itself to accepting the lowest bid, either wholly or in part or give any reason for such action. All prospective bidders will be screened in accordance with the National Treasury's Defaulters Data Base. Canvassing in any form in the gift of Council is strictly prohibited and will lead to the disqualification of the bid.
