All tender who previously tendered will get a free copy of the tender document upon producing a receipt or proof of payment of previous purchase.


A compulsory briefing session will be held **14 October 2020** at Sibusisiwe Hall, No 2 Thokoza Road, Sundumbili at 12h00.

The name and address of the Bidder must be clearly written on the sealed envelope containing the Bid Document. **Late submission, e-mail or fax bids will under no circumstances be considered.**

Only bidders registered on Central Supply Database (CSD) will be considered and must provide proof of registration.

The Mandeni Municipality subscribes to the Preferential Procurement Policy Framework Act, Act No. 5 of 2000 and its associated Regulations of 2017. The 80/20 principle applies to this Bid. Bids shall be valid for a period of 90 days. The Mandeni Municipality does not bind itself to accepting the lowest, or any Bidder, either wholly or in part or give any reason for such action.
