Bids are hereby invited from suitable service providers to provide Banking and Related Services to Mandeni Municipality for the period of five years.

and must be deposited in the tender box situated at the reception: Civic Centre, 2 Kingfisher Road, Mandeni **no later than 12H00 (closing time will ONLY be determined by the municipal watch at the reception) on 05 FEBRUARY 2021** at which time bids will be opened in public. The name and address of the Bidder must be clearly written on the sealed envelope containing the Bid Document. **Late submission, e-mail or fax bids will under no circumstances be considered.**

Only bidders registered on Central Supply Database (CSD) will be considered and must provide proof of registration.

The Mandeni Municipality subscribes to the Preferential Procurement Policy Framework Act, Act No. 5 of 2000 and its associated Regulations of 2017. The 80/20 principle applies to this Bid. Bids shall be valid for a period of 90 days. The Mandeni Municipality does not bind itself to accepting the lowest, or any Bidder, either wholly or in part or give any reason for such action.
