REQUEST FOR SERVICE PROVIDERS FOR THE FACILITATION OF YOUTH DRIVER'S LICENCE COURSE FOR A PERIOD OF 3 (THREE) YEARS

The Mandeni Municipality invites bidders from suitably qualified and experienced driving school service providers to facilitate the **Mandeni Youth Training on Full Driver's License Course for a period of 3 years**. Only Bidders who are registered as a Driving School, has Department of Transport Operating Certificate and registered on Central Supplier Database (CSD) will be eligible to Bid and must provide proof of registration with the above entities/bodies.


The physical address for collection of bid documents is: Mandeni Municipality, Civic Centre, 2 Kingfisher Road, Mandeni (cashiers office) upon presentation of a receipt proving prior payment of a non-refundable fee of **R500.00** (inclusive of VAT), (Cash or bank guaranteed cheques only). Bid documents will be available from **Tuesday, 17 NOVEMBER 2020 to Thursday, 26 NOVEMBER 2020** during working hours **Monday to Friday from 08h00 to 15h30 (Mon – Fri.)**.

Bids are to be completed in accordance with the conditions attached to the Bid document and must be sealed in an envelope and marked "**BID NO. 14/20/21: YOUTH TRAINING ON FULL DRIVERS LICENCE COURSE**" and be placed in the Bid Box situated at the reception: Civic Centre, 2 Kingfisher Road, Mandeni, **NOT** later than **12h00, on Friday, 11 DECEMBER 2020** at which time bids will be opened in public. Late submission, electronic or faxed bids will not be accepted.

The Mandeni Municipality subscribes to the preferential procurement policy framework Act, Act No. 5 of 2000 and its associated Regulations of 2017. The 80/20 principal applies to this bid. Bids shall be valid for a period of 90 days. The Mandeni Municipality does not bind itself to accepting the lowest bid, either wholly or in part or give any reason for such action.

All prospective Bidders will be screened in accordance with the National Treasury's Defaulters Data Base. Canvassing in any form in the gift of Council is strictly prohibited and will lead to the disqualification of the bid. No Bids will be considered from persons in the services of any organ of state. **A Compulsory Briefing session will be held on the 27 NOVEMBER 2020 at Sibusisiwe Community Hall in Mandeni**
