Bid documents will be available from Tuesday, 06 April 2021 to Monday, 19 April 2021 during working hours Monday to Friday from 08h00 to 15h00.


Bids are to be completed in accordance with the conditions attached to the Bid document and must be sealed in an envelope and marked: "Bid Number 42/20/21: Supply and Delivery of 1x Tar Mixer Mobile Asphalt Plant to Mandeni Municipality" and must be deposited in the tender box situated at the reception: Civic Centre, 2 Kingfisher Road, Mandeni not later than 12h00, on Monday, 26 April 2021. The Municipal watch displayed on the Municipal wall at the reception will ONLY determine closing time. Bids documents will not be opened in public however, the results will be published on the municipality's website. The name and address of the bidder must be clearly written at the back of the sealed envelope containing the bid. Late bids or bids received by way of post, facsimile or e-mail will, under no circumstances, be considered. ONLY bidders registered on the Central Supplier Database (CSD) will be considered and must provide proof of registration.

All prospective bidders will be screened in accordance with the National Treasury's Defaulters Database. Canvassing in any form in the gift of Council is strictly prohibited and will lead to the disqualification of the bidder.

Bidders are required to comply with and meet minimum threshold requirement in terms of products designated to date by the Department of Trade and Industry (DTI) of Local Production and Content on declaration certificate MBD 6.2.
