
A compulsory briefing session will be held on 14 October 2019 at Sibusisiwe Hall, No 2 Thokoza Road, Sundumbili at 10h00.

Bids are to be completed in accordance with the conditions attached to the Bid document and must be sealed in an envelope and marked: **"BID no.: 06/19/20 "SPATIAL DEVELOPMENT FRAMEWORK FOR MANDENI MUNICIPALITY"** and must be deposited in the tender box situated at the reception: Civic Centre, 2 Kingfisher Road, Mandeni **no later than 12H00, Friday, 18 October 2019** at which time bids will be opened in public. **Closing time will ONLY be determined by the municipal watch at the reception.** The name and address of the Bidder must be clearly written on the sealed envelope containing the Bid Document. **Late submission, e-mail or fax bids will under no circumstances be considered.**

Only bidders registered on Central Supply Database (CSD) will be considered and must provide proof of registration.

The Mandeni Municipality subscribes to the Preferential Procurement Policy Framework Act, Act No. 5 of 2000 and its associated Regulations of 2017. The 80/20 principle applies to this Bid. Bids shall be valid for a period of 90 days The Mandeni Municipality does not bind itself to accepting the lowest, or any Bidder, either wholly or in part or give any reason for such action.
