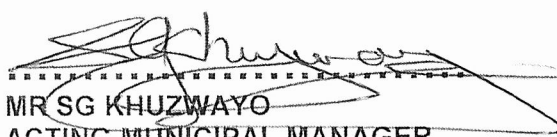
Bidders are hereby invited from suitably service providers to assist on Emergency Break Downs and supply parts to Mandeni municipality

Only Bidders registered on Mandeni Municipal Database and Central Supplier Database (CSD) will be considered.**
