The Mandeni Municipality invites tenders for the construction of Makhwanini Electrification in ward 9. Only Tenderers who are registered with CIDB in a contractor grading of 6 EP or higher and emerging contractors with a grading of 5 EP PE or higher will be eligible to tender. In case of Partnership /Joint Venture consolidated CIDB Registration Certificate must be attached. Tenderers will have proof of CIDB Registration by the closing date failing which the tender will be disqualified.

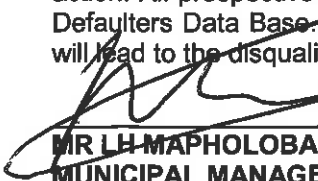

All prospective tenderers will be screened in accordance with the National Treasury's Defaulters Data Base. Canvassing in any form in the gift of Council is strictly prohibited and will lead to the disqualification of the tender.
