BID NO: 23/15/16 UPGRADE AND REFURBISHMENT OF MV LINE

Bids are hereby invited from suitably qualified and experienced contractors for the UPGRADE AND REFURBISHMENT OF MV LINE.

Only bidders who are registered with CIDB, in a contractor grading of 4EP/EB or higher will be eligible to bid.

Bid documents together with drawings will only be available at the cashier's offices, Civic Centre, 2 Kingfisher Road, Mandeni from Monday 29 February 2016 to Thursday 10 March 2016, during working hours that being **Monday to Friday from 08h00 to 15h30**. There will be **NO SELLING** of bid documents after 15h30 on Thursday, **10 March 2016**. A non-refundable fee of R500.00 will be charged per document.

A **compulsory** briefing/Site Inspection meeting will be held at **10h00 on Friday 11 March 2016**. Prospective bidders shall meet at the Technical Service Centre, 2 Croton Place, Mandeni thereafter proceeding to the site.

Bids are to be completed in accordance with the conditions attached to the Bid document and must be sealed in an envelope and marked: **"Bid Number 23/15/16: UPGRADE AND REFURBISHMENT OF MV LINE"** and must be deposited in the tender box situated at the reception: Civic Centre, 2 Kingfisher Road, Mandeni **not later than 12h00, on Friday, 18 March 2016** at which time bids will be opened in public. Closing time will **only** be determined by the Municipal watch displayed on the Municipal wall at the Reception. The name and address of the bidder must be clearly written at the back of the sealed envelope containing the bid. **Late bids or bids received by way of post, facsimile or e-mail will, under no circumstances, be considered.**

The Mandeni Municipality subscribes to the Preferential Procurement Policy Framework Act, Act No. 5 of 2000 and its associated Regulations of 2011. The 90/10 principle applies to this bid. Bids shall be **valid for a period of 90 days**. The Mandeni Municipality does not bind itself to accepting the lowest, or any tender, either wholly or in part or give any reason for such action.
