The Mandeni Municipality invites bids from Suitably Qualified and Experienced Service Providers To Supply And Install The Lightning Conductors For Three Years.

The physical address for collection of bid documents is Mandeni Municipality, Civic Centre, 2 Kingfisher Road, Mandeni (cashiers office) upon presentation of a receipt proving prior payment of a non-refundable fee of **R500** (inclusive of VAT), (Debit card, Cash or EFT: Ref no.: Bid No 43/22/23 Bidder's Name). Bid documents can also be emailed to bidders after submission of POP. The Municipal bank details may be requested via email from the Manager SCM. Bid documents will be available from **Wednesday, 21st June 2023 until Tuesday, 4th July 2023 from 08h00 until 15h30**. There will be no selling of bid documents after 4th July 2023 at 15H30.

A compulsory clarification meeting with representatives of the Employer will take place at the Sibusisiwe Hall, Mandeni on Wednesday, 5th July 2023, starting at 13h00. Failure to attend the compulsory clarification meeting with the bid document will disqualify the tender. The doors to the venue will be closed at 13h00 and no bidder will be permitted to enter afterwards. Bidders that do not bring the document to the briefing will be disqualified.

Bids are to be completed in accordance with the conditions attached to the Bid document and must be sealed in an envelope and marked: **"Bid Number 43/22/23: Suitably Qualified And Experienced Service Provider To Supply And Installation of Lightning Conductors for 36 months"** It must be deposited in the tender box situated at the reception: Civic Centre, 2 Kingfisher Road, Mandeni not later than 12h00, on **Friday, 21 July 2023** at which time bids will be opened in public. The Municipal watch displayed on the Municipal wall at the reception will ONLY determine the closing time. The Bidder's name and address must be written on the back of the sealed envelope containing the Bid. Late bids or bids received by post, facsimile, or email will be considered under no circumstances.

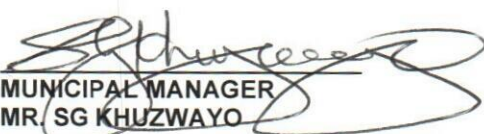
