Bidders are hereby invited from suitable qualified and experienced service providers for the "ESTABLISHMENT OF A PANEL OF CONSULTANTS FOR ELECTRICAL PROJECTS for a period of three (3) years.

The physical address for collection of bid documents is Mandeni Municipality, Civic Centre, 2 Kingfisher Road, Mandeni (cashiers office) upon presentation of a receipt proving prior payment of a non-refundable fee of **R600** (inclusive of VAT), (Debit Car, Cash or EFT: Ref no.: Bid No 22/23/24 Bidder's Name). Bid documents can also be emailed to bidders after submission of POP. The Municipal bank details may be requested via email from the Manager SCM. **Bid documents will be available from Monday**, 15<sup>th</sup> July 2024 until **Monday**, 29<sup>th</sup> July 2024 from 08h00 until 15h30. There will be no selling of bid documents after 29<sup>th</sup> July 2024 at 15H30.

Those bidders that had previously bought this document between the **23<sup>rd</sup> of April 2024 and 6<sup>th</sup> of May 2024** need not pay for it. They are required to provide the POP or receipt of the previous purchase and shall be provided with the bid document

Bids are to be completed in accordance with the conditions attached to the Bid document and must be sealed in an envelope and marked: "BID no.: 22/23/24 ESTABLISHMENT OF A PANEL OF CONSULTANTS FOR consultants for ELECTRICAL PROJECTS for a period of three (3) years" and must be deposited in the tender box situated at the reception: Civic Centre, 2 Kingfisher Road, Mandeni no later than 12H00, on Wednesday, 14th August 2024 at which time bids will be opened in public. Closing time will only be determined by the Municipal watch displayed on the Municipal wall at the reception. The name and address of the Bidder must be clearly written on the sealed envelope containing the Bid Document. Late submission, e-mail or fax bids will no circumstances be considered. Only bidders registered on Central Supply Database (CSD) will be considered.



The Mandeni Municipality subscribes to the preferential procurement policy framework Act, Act No. 5 of 2000 and its associated Regulations of 2022. Bids will be evaluated and adjudicated in terms of the Mandeni Municipality's SCM Policy. Bids shall be valid for a period of 120 days. The Mandeni Municipality does not bind itself to accepting the lowest bid, either wholly or in part or give any reason for such action. All prospective bidders will be screened in accordance with the National Treasury's Defaulters Data Base. Canvassing in any form of gift to Council is strictly prohibited and will lead to the disqualification of the bid.
