Mandeni Local Municipality is inviting students residing within Mandeni Municipality jurisdiction to apply for **registration fee assistance** to study at any recognized institutions of higher learning in South Africa. The purpose of this registration scheme is to provide financial assistance to potential students coming from historically disadvantaged backgrounds, who meet the requirements outlined below.

1. REQUIREMENTS

- a. Only citizens residing within the Mandeni Local Municipality jurisdiction may apply.
- b. Applicants must meet admission /entry requirements of the tertiary institution intending to study at.

2. WHAT DOES THE BURSARY ASSISTANCE PROVIDE FOR?

a. Registration Fee only.

3. WHO CAN APPLY?

- a. Matriculants or students who meet the set requirements (priority goes for matriculants/first entry students).
- b. Preference will be given to applicants who excel academically and/or demonstrate potential.
- c. Applicant must be enrolled to study at a recognized and registered institution of higher learning in South Africa.
- d. Applicant must be within the age group designated as youth, as per the Constitution of Republic of South Africa Number 108 of 1996.

THE FOLLOWING MUST ACCOMPANY YOUR APPLICATION:

e. Comprehensive CV (with contact details).

- f. Municipal bursary application form.
- g. Certified copies of ID & latest results.
- h. Guardian or parent's proof of income/ Affidavit
- i. Provisional letter of acceptance from a recognized institution. (If already secured)
- j. Brief motivation on why you must be considered
- k. Proof of address (the one only accessible from ward councilor)

4. Please take note:

- a. It is the responsibility of the applicant to submit all documents and fill in all the spaces on the application form in full.
- b. It is the responsibility of the applicant to attach all important documents to substantiate their application.
- c. It is the responsibility of the successful candidate to submit proof of registration with their institution's confirmation of banking details (stamped/signed by authorized official).

Applications must be submitted on the prescribed Mandeni Registration Fee Application Form obtainable from Mandeni Local Municipal reception, Youth Advisory Centre (love life), Mandeni Libraries and/or the Municipal website on www.madeni.gov.za.

Completed application forms stamped/signed by the ward councilor must be hand delivered by applicant at Mandeni Youth Advisory Center (Love Life) for the attention Mr N.M Mazibuko.
