Suitably qualified bidders are invited by suitable service providers to supply, install, configure, and maintain an Automatic Number Plate Recognition System (ANPR) in-car system (system only – the vehicle to be supplied by the Municipality)

Bid are to be completed in accordance with the conditions attached to the Bid document and must be sealed in an envelope and marked: **"BID NO.: 23/24/25 The Appointment Of A Service Provider To Supply, Install, Configure, And Maintain The Automatic Number Plate Recognition System (ANPR) In-Car"** and must be deposited in the tender box situated at the reception: Civic Centre, 2 Kingfisher Road, Mandeni **no later than 12h00, on 07 April 2025** at which time bids will be opened in public. Closing time will **only** be determined by the Municipal watch displayed on the Municipal wall at the reception. The name and address of the Bidder must be clearly written on the sealed envelope containing the Bid Document. **Late submission, e-mail or fax bids will no circumstances be considered. Only bidders registered on Central Supply Database (CSD) will be considered.**
