Bids are hereby invited from suitable service providers to be part of a panel of Professional Land surveyors and Town Planners for the Municipality Local Municipality.

Bids are to be completed in accordance with the conditions attached to the Bid document and must be sealed in an envelope and marked: "BID no.: 22/24/25 "PANEL OF LAND SURVEYORS AND TOWN PLANNERS FOR A PERIOD OF 3 YEARS FOR MANDENI MUNICIPALITY and must be deposited in the tender box situated at the reception: Civic Centre, 2 Kingfisher Road, Mandeni no later than 12H00 (closing time will ONLY be determined by the municipal watch at the reception) on **Wednesday, 16 April 2025** at which time bids will be opened in public. The name and address of the Bidder must be clearly written on the sealed envelope containing the Bid Document. Late submission, e-mail or fax bids will under no circumstances be considered.

Only bidders registered on Central Supply Database (CSD) will be considered and must provide proof of registration.

The Mandeni Municipality subscribes to the preferential procurement policy framework Act, Act No. 5 of 2000 and its associated Regulations of 2022. Bids will be evaluated and adjudicated in terms of the Mandeni Municipality's SCM Policy in two stages. First stage of evaluation is functionality and second stage being price and specific goals. Bids shall be valid for a period of



120 days. The Mandeni Municipality does not bind itself to accepting the lowest bid, either wholly or in part or give any reason for such action. All prospective bidders will be screened in accordance with the National Treasury's Defaulters Data Base. Canvassing in any form of gift to Council is strictly prohibited and will lead to the disqualification of the bid.
