Bids are hereby invited from suitable service providers for the establishment provision of a suitably experienced panel of service providers to supply and deliver building materials for the disaster management relief aid for a period of 3 years.

Bid are to be completed in accordance with the conditions attached to the Bid document and must be sealed in an envelope and marked: "BID NO.: 21/24/25 Appointment of a suitably experienced panel of maximum of 5 service providers to supply and deliver building materials for the disaster management relief aid for a period of 3 years", and must be deposited in the tender box situated at the reception: Civic Centre, 2 Kingfisher Road, Mandeni no later than 12H00, on Wednesday, 16 April 2024 at which time bids will be opened in public. Closing time will only be determined by the Municipal watch displayed on the Municipal wall at the reception. The name and address of the Bidder must be clearly written on the sealed envelope containing the Bid Document. Late submission, e-mail or fax bids will no circumstances be considered. Only bidders registered on the Central Supply Database (CSD) will be considered.

All prospective bidders will be screened in accordance with the National Treasury's Defaulters Data Base. Canvassing in any form of gift to Council is strictly prohibited and will lead to the disqualification of the bid.
