**ESTABLISHMENT OF A PANEL OF A MAXIMUM OF FIVE (5) PROFESSIONAL SERVICE PROVIDERS TO PROVIDE INTERNAL AUDIT SERVICES FOR A PERIOD OF THREE (3) YEARS**

Bidders are hereby invited from suitable service providers for the **establishment of a panel of a maximum of five (5) professional service providers to provide internal audit services for a period of three (3) years.**

Closing time will **only** be determined by the Municipal watch displayed on the Municipal wall at the reception. The name and address of the Bidder must be clearly written on the sealed envelope containing the Bid Document. **Late submission, e-mail or fax bids will no circumstances be considered. Only bidders registered on Central Supply Database (CSD) will be considered.**
